

LIMITED WARRANTY

Aftermarket Wheel End Components

Consolidated Metco, Inc. (Seller) hereby warrants to the Buyer that our products shall be free of defects in material and workmanship, as shall be determined by our manufacturing standards, and shall conform to the description on the face of this acknowledgment. This limited warranty applies to genuine ConMet aftermarket wheel end components or assemblies installed on vehicles operating in on-highway applications in the United States and Canada. The warranty period is effective from the original date of purchase of the aftermarket component or assembly from an authorized ConMet dealer or distributor. Part replacement under this warranty coverage does not extend the original coverage period. Coverage does not apply to parts replaced under OEM new vehicle or other extended coverage.

This warranty sets forth and describes Buyer's exclusive remedy and sets forth Seller's entire liability to Buyer. THE WARRANTY DESCRIBED HEREIN SHALL BE IN LIEU OF ANY OTHER WARRANTY, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. The terms contained herein constitute the entire agreement of the parties and warranty representations of the Seller. There are no other representations, warranties, or quarantees applicable to the sale of our products unless otherwise expressly agreed to by us in writing.

This limited warranty excludes any damage resulting from:

- 1. Removal of the aftermarket wheel end component to service other systems or components
- 2. Abuse, improper installation or adjustment, repair or modification; including improper wheel nut torque
- 3. Overloading
- 4. Damage resulting from the vehicle being involved in an accident or a natural disaster
- 5. Corrosion
- 6. Any failure that can be attributed to one or more components of a tire inflation system including, but not limited to, hub pressurization or contamination
- 7. Any failure to a ConMet aftermarket component caused directly or indirectly by third-party or aftermarket wheel end component including, but not limited to, spindle nuts, hub caps, lubricant, and gaskets.

This limited warranty shall not cover any collateral or progressive damage, including but not limited to: brake shoes/pads, drums/rotors, axles, nuts, etc., nor will it include cost of downtime on the equipment, roadside assistance, towing or loss of freight.

Buyer must submit itemized proof of purchase to be eligible for warranty consideration. All warranty claims must be submitted to the Warranty Department at Consolidated Metco, Inc. for warranty consideration. Seller will not accept the return of any products without the Seller's prior authorization that includes a Seller provided Return Goods Authorization (RGA number). Buyer will be reimbursed for return freight costs if the failure is deemed warrantable. No expenses incurred will be allowed under this warranty without the Seller's prior authorization. No warranty claims will be accepted 60 days after the issuance of an RGA number and validated repair date.

Buyer's exclusive remedy for any warranty claim, or for any claim arising out of the purchase or use of our products, shall be the replacement of said products. We will replace our products, without charge to the Buyer, FOB ConMet plant. We will not be liable for any consequential, incidental, or other damages sustained by Buyer, including but not limited to, loss of profits or revenue, loss of use of product, cost of capital, cost of substituted product, facilities, services, or claims of Buyer's customers for any damages. This exclusive remedy applies regardless of the nature of Buyer's claim, whether in contract, tort, express or implied warranty, negligence, or strict liability, upon which damages are claimed and regardless of whether the same is due to our negligence or any defect in our product.
